#### UNITED STATES COAST GUARD AUXILIARY COURSES FOR 2019

The U. S. Coast Guard Auxiliary, a volunteer non-military branch of the U. S. Coast Guard, like its parent is dedicated to insuring that our recreational boating is both safe and enjoyable. Two of its programs that are available to the public are especially directed to this goal: courses in safe boating practices and seamanship and boat inspections for safety equipment. During 2019 Flotilla 8-1 of the U. S. Coast Guard Auxiliary, based in Ocean City, is offering the ABC Course (About Boating Safely) as the 8-hour required course for the Boating Safety Certificate of the State of New Jersey.

The cost of *About Boating Safely* is \$60.00 per person. A concise course text is provided. Successful completion leads to the required State certification. The fee of \$60.00 per registrant covers all aspects of the course, including State registration and lunch.

#### *GPS for Mariners*

Replacing our prior GPS course is a modern learning experience that focuses on the GPS equipment typically owned by the recreational boater. *GPS for Mariners* is a course that has resulted from an exciting synergy between textbook's publisher, the book's author, and the Auxiliary. Cost for the course, per person, is \$25.00

#### *VESSEL SAFETY CHECKS*

In this free service to the boating public, an Auxiliary Vessel Examiner checks the safety equipment of the boat. This vessel examiner is specially trained and meets Auxiliary qualifications. The "Seal of Safety" decal awarded indicates that the boat has met not only the federal and state regulations and safety requirements, but has also satisfied Auxiliary requirements that may go considerably farther in some areas.

Since it is conducted in a "one-on-one" basis, the examination becomes an opportunity for valuable exchange of boating safety information. The use of flotation devices, fire extinguishers, distress signals, blowers, anchors, the marine radio are demonstrated. #### *LEGAL REQUIREMENTS*

**ALL** persons who wish to operate a vessel in the State of New Jersey **MUST** have a **New Jersey Boating Safety certificate**. (If you are from PA, your PA certificate is good for 90 days or less.)
